5. Administrative Reports

Two Roses and a Thorn

In place of sharing monthly updates Administrators were asked to share two positive things (roses) and a difficulty (thorn) that they have experienced in the month.

Merri Rajaniemi, Brownfield Denmark School - Rose: Our overall attendance for the year is 96%, which is less than our goal of 97%, we have had a variety of reasons for students to be out of school. We have had a total of 70 days of perfect attendance. Our Kindergarten class has had perfect attendance 20 out of 27 days and our first grade class has had perfect attendance 19 days. Also, we have seen a reduction in the number of students who were chronically absent last year compared to this year. The second rose is our Staff is working hard to build relationships, get to know their students, make connections and build a sense of community. This is noticeable throughout the day, but especially at arrival and dismissal. Students are excited to see their peers, they wait and walk in together, they smile and hug. In the afternoons, they say goodbye to their friends as they're picked up. It's really heartwarming to observe. Our Thorn has to do with the reduction in staff and the lack of substitutes. We have lost a special ed teacher, who was only half time at our school, a regular ed tech, and we only have a half-time counselor.

Carolyn Lewey, New Suncook School: Rose: We have been having great attendance with an average of 96%. This is a little below the goal but several classes have had perfect attendance. They are establishing good relationships with families to encourage good attendance. The Great Outdoor Company (formerly Timbernook) is great at bringing outdoor skills back into the classroom. Carolyn thanked Eli Hutchings tree service for all of his work over the summer cleaning up the outdoor area. Thorn: They have seen

perplexing behaviors schoolwide and it is taking a toll on the staff with many people wearing multiple hats. Staff are working together to support each other.

Pat Menzel, Special Services: Rose: Team members have been great in working together especially having to deal with vacant positions. Thorn: Special Services is taking on all Pre-K services and doing this along with having to deal with staffing issues has been very challenging.

Emily Kirkpatrick, Molly Ockett School K-5: Rose: We are really focusing on good attendance and reaching out to families. We had a successful back to school night. We have started an October attendance initiative with some great success. We had a K-4 community meeting at the end of the month with 4th graders presenting their slide show about their Channel 8 spot on the news. School Counselor, Colleen Michaels put together a great slide show with pictures of the students. Thorn: We still have students with chronic absenteeism but we are working hard to get to the root cause. Teachers and nurses are working with families

Matt Lokken, Molly Ockett School 6-8: Rose: We started the school year for the first time in three years fully staffed. Teachers are working hard. Our athletic teams are fully staffed and we have an amazing new assistant athletic director, Alyssa Randall. There are 93 students participating in athletics which is over a third of 6-8 students. Thorn: The substitute pool is very shallow - very challenging when it comes to staffing but we do have some new sub applicants.
